Enchanted Lands Enterprise, its operators and agents will not be responsible for any act, error, or omission, nor for any injury, loss, accident, delay, inconvenience, irregularity, or damage which may be occasioned by any cause whatsoever, including acts of nature, civil disturbance, government restrictions, or failure of any means of a conveyance to adhere to published schedule.

Enchanted Lands Enterprise reserves the right prior to departure, and after departure, to re-price, cancel, or withdraw any tour for any reason whatsoever, and to alter or omit any part of the itinerary, to substitute hotels or leaders, or to change any means of conveyance without notice, and without allowance of refund, with the liability of increased cost - if any - to be borne by the tour participants. I willingly accept the risk and uncertainty involved as being a part of my adventure. I hereby accept and assume full responsibility for any and all risks of illness, injury, or death due to the negligence (but not reckless, willful, or fraudulent conduct) of Enchanted Lands Enterprise, its employees, agents, contractors, or other affiliated organizations of any of their employees. I agree not to sue, and to release from liability and indemnify Enchanted Lands Enterprise, their owners, employees, agents contractors and other persons involved with this tour, from all actions, claims, or demands of injury or damage regardless of the cause, resulting from my participation in the tour.
